



Accelerating Appraisals and Conservation Efforts (AACE) Act

Led by Reps. Susie Lee (D-NV) and Dave Joyce (R-OH)

Why do we need this bill?

The Department of the Interior (DOI) is America's principal land management agency, charged with administering roughly 420 million acres of federal lands, nearly 55 million acres of Tribal lands, more than 700 million acres of subsurface minerals, and about 2.5 billion acres of the outer continental shelf. Any time that DOI and its bureaus — including the Bureau of Land Management (BLM) and the National Park Service (NPS) — buy, sell, lease, trade, or conduct any type of land-related activities, these activities must be done at fair market value to protect the public trust.

As the number of desired DOI land-related activities continues to increase nationwide, so, too, are appraisal bottlenecks, slowing progress on key land transactions and threatening to undermine longstanding DOI projects and partnerships essential to achieving a range of conservation, economic, and housing goals. With the Land and Water Conservation Fund now permanently and fully funded — and with communities across the country actively seeking to collaborate with DOI on land transactions vital to progress and preservation alike — the demands on the Department grow greater by the day.

In FY 2022, DOI completed more than 294 federal land valuation cases representing approximately 214,000 acres; the Department now faces an "expected surge" of requests across FY 2023 and FY 2024, during a nationwide appraiser shortage that has depleted DOI's own appraisal workforce. "Staffing to meet current and anticipated increases in demand," the Department emphasizes, "remains a challenge."

What would this bill do?

In 1992, recognizing that the United States has a compelling interest in facilitating appraisal work on behalf of the federal government across state lines, the Bush-Quayle Administration directed that federal employees who are appraisers only need to be licensed or certified in one state or territory to perform appraisal duties on behalf of the federal government in all states and territories.ⁱⁱ Today, however, for DOI to meet its fast-growing appraisal obligations, the Department must regularly contract with private appraisers throughout the country. This slows DOI's appraisal workflow, as private appraisers must currently be credentialed in each state where contracted by the Department.

The bipartisan *Accelerating Appraisals and Conservation Efforts (AACE) Act* addresses this inefficiency by allowing DOI to contract with private appraisers appropriately credentialed in any one state or territory to perform appraisal duties across all states and territories. It builds on the 31-year-old precedent established under President George H.W. Bush to maximize the efficiency of DOI's appraisal process with no additional appropriations and minimal changes to existing regulations. This bill is a commonsense, bipartisan fix to alleviate a government backlog that currently inhibits states, municipalities, and communities nationwide from accomplishing their conservation, economic, and housing goals.

Specifically, this bill would:

- Enable DOI to contract with private appraisers who are appropriately credentialed in one state or territory to perform appraisal and valuation services on DOI's behalf in any state or territory.
- Require DOI to continue to prioritize contracting with local appraisers to the maximum extent practicable, unlocking the enhanced flexibility provided by the bill only when no assignment-qualified or cost-competitive local appraisers are available to perform needed services.
- Direct DOI to report to Congress on the effectiveness of this enhanced flexibility as well as provide annual updates on the status of its appraisal workflow, workforce, and workload.
